

NE multispecies Information Sheet - Landing Possession/Size Limits

This summary is not a substitute for the regulations; rather it provides a broad overview of restrictions and requirements. You are strongly encouraged to read the regulations in conjunction with this information sheet to fully understand how this fishery is managed. The regulations described here can be found at 50 CFR 648.83, 648.85, and 648.86, and will be updated when regulations are revised.



Common pool vessels are subject to the trip limits below; the Regional Administrator has authority to revise trip limits to ensure that ACLs allocated to the common pool are not exceeded (revisions in bold type). Sector vessels are exempt from the trip limits with the exception of Atlantic halibut and prohibited species, but must still abide by minumum fish sizes.
